CATALONIAN NATIONAL RESEARCH AWARDS 2020 EDITION

The Government of Catalonia has among its objectives to promote the social recognition of science and particularly to disseminate the international work of Catalanian researchers throughout our society. These activities are carried out by, among other entities, the Fundació Catalana per a la Recerca i la Innovació (FCRI).

With these goals in mind, the Government of Catalonia, through the FCRI, announces the following awards:

- Catalanian National Research Award
- Catalanian National Research Award for Young Talent
- Catalanian National Research Award for Scientific Communication
- Catalanian National Research Award for Scientific Patronage
- Catalanian National Research Award for Public-Private Partnership in R&I
- Catalanian National Research Award for Creating a Science-based Enterprise



CATALONIAN NATIONAL RESEARCH AWARD

AIM

The Government of Catalonia, through the FCRI, will award this prize to an outstanding researcher working within the Catalan system of research and innovation, including businesses and foundations, who has made a significant international contribution to their scientific discipline in any of its areas: humanities and social sciences, life and health sciences, or experimental science and technology. Other aspects such as technology transfer and the social impact of his or her research will also be assessed.

REQUIREMENTS

Nomination by universities (governing bodies, faculties, schools, departments), research centres, university research institutes, academies of science, businesses and foundations, previous winners of the Catalan National Research Award, or in general, any agent of Catalan research and innovation.

Candidates must have a recognized relationship with Catalonia. It is essential that they are from the region, have worked there or are working there now. Candidates must be nominated by one of the bodies or persons mentioned above; self-nomination is not permitted.

PRIZE

The prize consists of a statuette designed by the sculptor and ceramic artist Jordi Serra, along with an award of EUR 40,000.

CATALONIAN NATIONAL RESEARCH AWARD FOR YOUNG TALENT

AIM

The Government of Catalonia, through the FCRI, will award this prize in recognition of the outstanding effort of a junior researcher, from the Catalan system of research, including businesses and foundations, who is undertaking his or her research activity outside Catalonia, whose professional career has been characterised internationally by the quality and excellence of his or her scientific research work. Other aspects such as technology transfer and the social impact of his or her research will also be assessed.

REQUIREMENTS

Nomination by universities (governing bodies, faculties, schools, departments), research centres, university research institutes, academies of science, businesses and foundations, previous winners of the Catalan National Research Award, or in general, any agent of Catalan research and innovation.

Nominees must be aged under 40 at the closing date of this announcement and be currently developing their scientific activity in Catalonia. Candidates must be nominated by one of the bodies or persons mentioned above; self-nomination is not permitted.

For female researchers, the age limit of 40 years will be increased by one year per child accredited.

PRIZE

The prize consists of a statuette designed by the sculptor and ceramic artist Jordi Serra, along with an award of EUR 10,000.

YOUNG TALENT

Nominations may be presented on the FCRI website (www.fundaciorecerca.cat/premi), which contains all the information necessary to nominate a candidate and present supporting documentation.

The following documentation is required: general candidate information, special distinctions (number of theses, patents, awards, honors, etc.); nominee's complete curriculum vitae (in Word or .pdf); and summarised description of nominee's merits.

The deadline for nominations is 2 November 2020 at 14:00. Nominations that fail to submit the supporting documentation before that time will not be considered.

The awards ceremony will be held in Barcelona and will be presided over by the President of the Government of Catalonia.

CATALONIAN NATIONAL RESEARCH AWARD FOR SCIENTIFIC COMMUNICATION

AIM

The Government of Catalonia, through the FCRI, will award this prize in recognition of an outstanding activity in scientific communication whose goal is to promote and strengthen the public's interest in science.

REQUIREMENTS

The jury will choose the best scientific communication and initiative carried out in Catalonia among all of the existing media formats (digital or print publications, radio and television, internet, exhibitions, festivals, etc.), as well as professionals working in this area.

PRIZE

The prize consists of a statuette designed by the sculptor and ceramic artist Jordi Serra.

CATALONIAN NATIONAL RESEARCH AWARD FOR SCIENTIFIC PATRONAGE

AIM

The Government of Catalonia, through the FCRI, will award this prize to recognise and stimulate private collaboration and financial support to philanthropic research work in Catalonia and internationally.

REQUIREMENTS

The jury will grant an institutional award in recognition of an individual, company or organization for their donations or contributions to generating philanthropic resources to promote and support scientific projects in Catalonia.

PRIZE

The prize consists of a statuette designed by the sculptor and ceramic artist Jordi Serra.

CATALONIAN NATIONAL RESEARCH AWARD FOR PUBLIC- PRIVATE PARTNERSHIP IN R&I

AIM

The Government of Catalonia, through the FCRI, will award this prize in recognition of an outstanding activity carried out through a public-private partnership in research or in the general area of public-private cooperation in research and innovation activities in Catalonia.

REQUIREMENTS

The jury will recognise an individual, organisation or company for their activities in fostering cooperation between the public and private sectors in research activities and in mobilising private financing for R&I.

PRIZE

The prize consists of a statuette designed by the sculptor and ceramic artist Jordi Serra.

CATALONIAN NATIONAL RESEARCH AWARD FOR CREATING A SCIENCE-BASED ENTERPRISE

AIM

The Government of Catalonia, through the FCRI, announces this prize in recognition of a science-based company created within the Catalan public or private research system, whose activity has emerged from academic environment. By this we mean that it comes directly from research at university or a recognised non-profit research centre. Its purpose is to promote the creation of science-based companies to recognise the importance of translating research results into society and to highlight the socio-economic potential and the well-being of society creating research-based companies.

REQUIREMENTS

The 12 Catalan universities and recognised non-profit research centres within the Catalan R&D&I system can participate in this category by creating a research-based company with \leq to 2 years and with TRL (Technology Readiness Levels) \geq 4.

The prize goes to university or research centre driving the science-based company.

Evaluation indicators:

1. To help solve the desire or need by the idea raised.
2. Strategy for protecting the intellectual property of the idea.
3. Development plan or business plan of the science-based company including interested potential customers (public or private sector).
4. Participation in private funding rounds or public co-funding.

PRIZE

The prize consists of a statuette designed by the sculptor and ceramic artist Jordi Serra.

CREATING A SCIENCE-BASED
ENTERPRISE

Nominations may be presented on the FCRI website (www.fundaciorecerca.cat/premi), which contains all the information necessary to nominate a candidate and present supporting documentation.

The following documentation is required: general information on the candidate organisation/initiative/individual; summary of candidacy; complete description and, if appropriate, the social, economic and international impact of the candidate (in Word or .pdf).

The FCRI's board has the capacity to suggest and propose nominations of people, organisations and initiatives in any of these four categories. The Jury of the awards can also suggest and propose nominations in any of the same four categories, that will not be considered until the next call for awards.

The deadline for nominations is 2 November 2020 at 14:00. Nominations that fail to submit the supporting documentation before that time will not be considered.

The awards ceremony will be held in Barcelona and will be presided over by the President of the Government of Catalonia.

JURY OF THE CATALONIAN NATIONAL RESEARCH AWARDS

The jury will consist of the president of the FCRI, who will act as chair; the Secretary of Universities and Research of the Catalanian government; the Director General of Research of the Catalanian government; and six external experts of recognised prestige, appointed by the chair. The director of the FCRI serves as secretary, with no right to vote but reserving the right to participate in deliberations.

One indivisible prize will be awarded in each category to a single person or organisation.

The jury will decide the name of the winner before 31 December 2020. The prize may be declared void.

The names of winners will be published on the FCRI website (www.fundaciorecerca.cat).
